Description of services and Products Covered

- 1.) Part of this collection includes an Engagement Session. The session will be pre-arranged via telephone and locations and themes agreed upon. An appointment is scheduled as soon as possible. Shari DeAngelo Photography makes every effort to meet your busy schedule, but no guarantees can be made. Scheduling early will provide all parties a better experience and better product in the end.
- 2.) Your coverage includes two professional photographers to cover the events of your day. Both begin their coverage with the bride and groom getting ready and end at the conclusion of the reception, unless otherwise agreed upon.
- 3.) All images are custom tailored to fit the style and location of the event. All processing is done in house and will meet the high quality standard of Shari DeAngelo Photography. We don't limit how many images you will receive that day. If we believe it's a quality image that tells the story of the day as it unfolds, we're pleased to include it. The length of your day, the amount of details (cake, floral, room display, etc will affect the number of images you may see after the event. We reserve the right to pick "best of" of any series of images taken and to not include an image due to it not meeting the quality standard we seek to maintain.
- 4.) A Custom designed web gallery with a slideshow set to music will be posted for you to share with family and friends. We provide a onetime courtesy to Brides and Grooms to remove any images that they prefer to keep private. This gallery is password protected and is emailed only to Bride and Groom, unless otherwise agreed upon. Galleries can be posted online anywhere from 4-8 weeks after the wedding day, depending on the time of year. It, by default, expires after 90 days. The gallery contains a fully functional shopping cart feature for you and your family and friends to make purchases after your wedding day.
- 5.) A DVD/set with all your images from your day in print ready JPEGs. This will include all images in your web gallery, ready for you to backup to your home computer and to make any additional prints from. Although these should print fine with any reputable printing lab, Shari DeAngelo Photography cannot make guarantees on prints that are provided by other vendors. We also do not recommend you print large gallery quality images, such as the ones you will hang in your home from these files. Special processing is required for large prints (over 8x10). Those are not included in this wedding collection. Hi-Resolution files are for your own personal use and reprinting needs. Uploading the high resolution "Print Files" to a photo sharing site (such as Facebook, SnapFish, Flickr, etc) for others to order prints, is against international copyright and illegal. See below regarding web images.
- 6.) All images that are in your web gallery will be included in your DVD set, fully optimized for web viewing. They are great for social networking sites, such as Facebook, or personal blogs and sites. They are not optimized for print, at any size, but are free for you to use and share. They are watermarked. Removing the watermark is not permitted under this contract.

7.) You will have your choice of one of the Standard Album choices. You can choose from one of six we carry from Leather Craftsmen (2) or Couture Book (4). We choose these books for their style, guarantees and exceptional craftsmanship. Sample Books are available for the you to view. You will also have a Wedding Collections Book Choices (PDF) to view and download on your private Concierge Page with all available options to you under this collection. Other book options are available at your request.

This package includes one Standard 10x10 album with a minimum of 20 sides (approximately 40-50 images) custom designed by Shari DeAngelo. Additional pages (sides) are available for an additional fee, at any time prior to final book order. Current pricing is available on your Concierge Page and is guaranteed through the length of this contract and up until 90 days after the online proofing gallery has been posted to the website. Shari DeAngelo stands behind the quality and craftsmanship of all products and provides a 100% Satisfaction Guarantee.

Any of the standard books are included under this contract and may be chosen at any point **before or after your wedding day. Once you are ready, we'll take your order over the phone** and send you the Final Order for your approval. We'll also send an invoice with any add-on options you have chosen, if applicable. If there is a balance due for any add-ons or upgrades, **we'll hold the order for up to 7 days** for payment to arrive. After that, you may have to place your order again and prices may not be guaranteed to be the same

Many clients prefer that we predesign their book for them, so that has become standard practice for us. We send a proof layout and you can make up to 2 revisions. Alternatively you may request the images to be included up front if that's your preference.

Terms and Conditions of Agreement

The parties agree that Shari DeAngelo Photography (hereby referred to as "Photographer") will furnish the services of exclusive professional photographer, for the specified day and times for Bride and groom named and addressed above (hereby referred to as "Clients"). This coverage includes bride and groom getting ready (typically a couple hours prior to wedding start) and ends at the conclusion of the reception. Additional time may be added at the end of the reception, at the bride and groom's request for an additional \$125 an hr, per photographer.

This Collection includes color corrected, stylized photos for both web and print. Some basic skin retouching may be done on web images as a courtesy but are not required under this agreement. Images chosen for album or prints from the Photographer's lab are fully retouched at no additional charge. Photographer will make every attempt to make necessary edits to please client but reserves the right to charge digital processing time at \$125/hr for unreasonable or persistent changes or retouching that goes beyond standard portrait requirements (ie. braces removal).

Every effort is made to keep digital negatives (*) and processed digital images backed up and safe for many years to come, but can only be guaranteed for 1 year after the date of the wedding.

**A digital negative is a raw image data file. It requires special software to read, correct, and save as a JPG, TIF, PSD, GIF, etc. It is used by most professional photographers as they can maintain more control in the end result than allowing the camera to make these decisions.*

Credentials and Coverage

Shari DeAngelo Photography always recommends weddings have a minimum of 2 photographers to assure best coverage to protect clients from having to deal with such emergencies as delays, equipment failure or illness of any one photographer. Exceptions may be made, in rare occasions to our rule (ie. very small weddings). In the unlikely event of these or other circumstances beyond the control of the Photographer, a substitute photographer of high qualifications may be sent to fulfill the obligations of the Photographer herein contracted. As much advance notice as possible will be given client, if such a circumstance exists.

Specific Photographs and Liability

The photographer will make every effort to assure your satisfaction according to accepted industry standards. Any artistic interpretations by the photographer will be deemed acceptable and correct. Due to the changing and fluid nature of this type of event, the photographer does not **guarantee the production of any specific image(s). Events outside of the photographer's control**, such as weather, late arrival of subjects, missing persons, short timelines, guest interference, intoxicated individuals, venue restrictions, acts of terrorism, etc. may preclude the creation of some images. Shari DeAngelo Photography assumes no liability for failure to comply with the **terms of this Agreement due to events outside of the photographer's control.**

Limitation of Liability

While every reasonable effort will be made to produce and deliver outstanding photographs of **the wedding events, the Photographer's entire liability to the Clients for any claim arising from the Photographer's performance** is limited to a refund to the Clients of the amount paid for services. Because a wedding is an uncontrolled event, the Photographer cannot guarantee delivery of any specifically requested image(s).

Features Offered

The products and prices listed are current at the time of contract signing. If, for some reason the products are not available, photographer will work with client to find suitable replacements for no additional charges. At any time, prior to final album prints being ordered, substitutions and additions may be made. **For the client's convenience and for that of their family and friends,**

Studio makes prints, books and other products available for purchase via client's password protected web pages. Client has full discretion over who may view these pages by sending out guest passes and passwords and each visitor may individually purchase prints. The studio ships these orders directly to the purchaser. The Web Gallery will remain available to anyone with login information for a minimum of 90 days after being published.

Exclusivity

It is agreed that Shari DeAngelo Photography will be the exclusive commercial photographer providing still prints for or at this event. Others may take photographs or record video as long as they do not interfere with the duties of the Photographer or her staff. Other photographers, paid or unpaid, who attempt to photograph or record the same poses or scenes during the same time period as the Photographer may detract from the quality of the **studio's images, and may** be cause for the Photographer to cease work until such interference ends. For this reason we request guests to wait until after the formal portraits are completed before taking their own photos. The Photographer will not be responsible for time or images missed as a result of such interference.

Copyright and Reproductions

It is agreed that Shari DeAngelo Photography shall own the copyright to all images created through this contract. Shari DeAngelo Photography, LLC shall have the exclusive right to make **reproductions for the Client/s or for the photographers' portfolios, samples, self-promotions,** entry in photographic contests or art exhibitions, editorial use, for display within or on the **outside of the photographers' studio, including the World Wide Web.** The Client will receive a Print Release form with their Hi-Resolution DVDs. No image over 900 pixels high or wide may be published to any photo sharing site on the web. Any web-optimized images (900 pixels or less) that have watermarks on them cannot be altered in any way. Unauthorized copying or use of the Photographer's images is an infringement of Federal Copyright Law and a violation of this contract. Unless expressly provided in an addendum this contract does not provide the Client/s with any ownership of or rights to use the negatives or digital image files created under this contract.

Storage of original files

We make every effort to backup files and store them indefinitely, but cannot make guarantees beyond 1 year after your event date.

Retainer Payments

Once the studio reserves a date/time for the Client/s, it ceases to sell its services for this date/time to others. If the event is cancelled or postponed, the Studio suffers a loss. Therefore, **RETAINERS ARE NOT REFUNDABLE UNDER ANY CIRCUMSTANCES.** If the studio is able to re-book a

date/time for which it has received a cancellation or postponement, it may, at its sole discretion, provide a Studio Credit to the Client/s for what, in the Studio's sole judgment, is a reasonable portion of any payments made by the Client/s. Payment in full is required prior to any work being performed. Any failure of scheduled payments may, at the discretion of Studio, void contract and/or put a hold on any services or products from being delivered.
